The valves are available in two materials of construction: stainless steel and cast iron. The cast iron valves are also available nickel or chrome-plated or Tungsten coated.

The standard rotor has 9 blades. Various rotor configurations are available, such as adjustable or fixed blades, reduced capacity, scalloped fixed vaned, end disc etc. The end covers have outboard bearing, lubricated and sealed for life. Shaft seals are available with gland packing or lipseal and optional air purge.

The standard models are suitable for products up to a temperature of +302°F and a maximum pressure differential of 29 PSI. Special configurations are available to accommodate temperatures between -328°F and +1112°F. Pressure shock resistant up to 145 PSI and explosion-proof models are also available. All models offer optimum venting through large vent holes, which are drilled to order.


